Na'e fakatupunga 'e he tolalo faka'ekonomika 'a e holo 'i he ngaahi vaka na'e tau mai mo e fehuaki 'a e koloa lolotonga e ta'u 'one uesia ai 'a e fakahokofatongia mo e pa'anga humai fakakatoa 'e \$7,076,328. Lolotonga 'a e ta'u fakapa'anga na'e fakahoko 'e he Ma'u Mafai ha ngau'e ki he ngaahi palopalema nae teeki ai ke lava o solova mei he kuohili o pau al ke fakahoko hangaahi fakatonutonu 'o ne uesia ai e tuunga tupu a e Ma'u Mafai. Ko e pole lahi foki ki he kau Talekita mo e Kau Pule Ngau'e ko e fakamole ki he Naunau mo e koloa ke lava ke fakahoko lelei mo malu hono fatongia 'ai a 'oku fakafuofua ki he \$4.0 milliona.

Fakamatala fekau'aki pea mo e ngaahi tulanisekisoni fakapa'anga he vaha'a 'o e Kautaha pea mo e Ngaahi Kautaha 'a e Pule'anga, honau ngaahi Va'a pea mo e Pule'anga he ta'u kuo mahili atu, kau ai;

(i) ha koloa kamata 'o tatau pe 'i he founiga 'o e noo pee 'ikuiti , 'a e lahi 'o e pa'anga kola, ko e totongi tupu, kapau 'oku fekau'aki, pea mo e teemi 'oku totongi fakafokai ai;

Na'e ikai ha pa'anga na'e to e fakahu mai mei he Pule'anga ko ha fakalahi honau inasi ki hono fakalele 'o e Ma'u Mafai 'i he ta'u fakapa'anga kuohili.

(ii) ko e kotoa 'ae ngaahi no 'oku malu'l 'e he Pule'anga ki he lelei 'a e kautaha 'a e pule'anga koia;

Oku 'ikai ke 'i'ai ha no 'a e Ma'u Mafai 'oku malu'l 'e he Pule'anga.

(iii) ko e lahi 'o e totongi fakapa'anga mei he Pule'anga ki he ngaahi sevisi 'a e kautaha 'o laka hake he peseti 'e 10'o e pa'anga hu mai fakata'u, ko ha fakamatala nounou ki he ngaahi sevisi ko'enai;

Ko e lahi 'a e pa'anga kuo totongi mai 'e he Pule'anga ki he Ma'u Mafai 'i he koloa mo e ngaahi ngau'e lolotonga 'a e ta'u fakapa'anga 'oku si'l hifo ia 'i he peseti 'e 10'o e pa'anga humai fakalukufua 'a e Ma'u Mafai ki he ta'u fakapa'anga.

(iv) Ko e totongi fakapa'anga ne fai 'e he Pule'anga, 'okapau 'oku lahi hake 'ae totongi ko'enai he peseti 'e 10'o e koloa kamata 'o e kautaha 'a e pule'anga koia, ko ha fakamatala nounou ki he 'uhinga 'o etotongi koia pea kau ai mo e fakamatala pe 'oku pau ke totongi fakafokai 'a e kotoa 'o e totongi pa'anga koia pe ko hano konga.

Na'e 'ikai ha fa'ahinga totongi na'e fakahoko 'e he Pule'anga ki he Ma'u Mafai ne hulu hake he peseti 'e 10'o e inasi fakakatoa 'o e Pule'anga 'i he Ma'u Mafai.

The depressed economic situation resulted in reduced shipping movements and tonnage handled during the 2009/10 financial year which in turn impacted on reduced business with total income of \$ 7,076,328. The Authority addressed a number of long standing unresolved issues resulting in extra-ordinary balance sheet adjustments during the financial year which impacted negatively profitability. A major challenge for Directors and Management is the significant capital expenditure required to deliver efficient and safe operations which is estimated at \$4.0 million.
